### Description

The MBA in Auditing at the University of Professional Studies, Accra, develops experts in audit practice, assurance services, and corporate governance through a balance of theory and application. It builds technical, analytical, and ethical competence to evaluate financial systems, ensure compliance, and enhance accountability across private, public, and non-profit sectors. The curriculum integrates core business studies, strategy, economics, marketing, organisational behaviour, and financial management, with specialised modules in auditing, forensic and public sector auditing, assurance services, taxation, and risk management. Students gain a deep understanding of auditing principles, international standards, and the regulatory environment driving financial integrity. The inclusion of forensic auditing addresses the growing need for professionals who detect and prevent fraud. Emphasising leadership, ethics, and professionalism, the programme connects students with industry leaders through the Practitioners' Forum, sharpening communication and executive skills. Research and project work strengthen their ability to address financial governance challenges through evidence-based solutions. Graduates emerge prepared for senior roles as auditors, risk managers, assurance specialists, forensic investigators, and compliance officers in accounting firms, regulatory bodies, corporations, financial institutions, and the public sector. Grounded in integrity and accountability, they are equipped to uphold and advance the financial systems that sustain organisational and economic trust.

- Apply assurance services to enhance organisational accountability.
- Evaluate public sector financial reporting and governance systems.
- Investigate fraud through forensic auditing techniques.

- Analyse and mitigate enterprise and financial risk.
- Lead ethically in business and governance environments.
- Integrate information systems into auditing and assurance practice.
- Undertake applied research in auditing and financial management.
